As recommended by the J&K Services Selection Board vide Letter No SSB/Secy/Sel/2018/7751-57 dated 06-07-2018, sanction is hereby accorded to the temporary appointment of below noted candidate as Junior Assistant in the J&K Employees Provident Fund Organisation in the pay level of (Rs. 25500-81100) {Pre-revised (5200-20200) with the grade pay of Rs. 2400} with immediate effect:-

The above appointee shall report to the Additional Provident Fund Commissioner, Railway Road, Jammu within 21 days from the date of issuance of this appointment order. In case the appointee fails to join within the stipulated period of 21 days, his appointment shall be deemed to have been cancelled abinitio without any further notice.

The appointee shall be allowed to join only on production of the following certificates in original:-

- (1) Academic/Technical Qualification Certificates.
- (2) Matriculation/Date of Birth Certificate.
- (3) Health Certificate issued by the Chief Medical Officer.
- (4) Permanent Resident Certificate issued by the Competent Authority.
- (5) Certificates from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
- (6) Relevant category certificate.

The appointment of the above candidate as Junior Assistant shall further be subject to the following conditions: -

- (i) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from Inspector General of Police, (CID), J&K, to whom a reference shall be made by the Additional Provident Fund Commissioner, Jammu, the candidate shall have no right to claim his appointment as Junior Assistant and his appointment as such shall be deemed to have been cancelled ab initio.
- (ii) The verification/genuineness of all the required certificates viz Academic/technical qualification certificates, Matriculation/ Date of Birth Certificate, Permanent Resident Certificate, Health Certificate, NDC from General Manager, District Industries Centre and Deputy Director Employment of concerned District, Relevant Category Certificate to be got done by the respective DDO.

The salary of appointee shall not be drawn and disbursed unless the satisfactory report in respect of (i) and (ii) above are received in his favour.

The appointee shall be on probation for a period of two years during which he shall undergo such training and pass the Departmental Examination as may be prescribed.

The appointment of the above candidate shall be subject to the final outcome of writ petition (s), if any, pending before any competent Court of Law.


